Mr Nami was Executive Chairman of the Federal Inland Revenue Service (FIRS) from 2019 to 2023. He had logged about three decades of high-flying career in Accounting, Auditing, Management and Tax Advisory Services before he was head-hunted to lead the FIRS in 2019.

Mr Nami proved that he was the person the job had been waiting for when he immediately introduced earth-shaking reforms that repositioned the FIRS. While in office as the Executive Chairman of FIRS, Mr. Nami also functioned as the Chairman of the Joint Tax Board (JTB), Chairman of the African Tax Administration Forum (ATAF) and President of the Commonwealth Association of Tax Administrators (CATA). These roles enabled him to showcase his professional and managerial skills beyond the shores of Nigeria.

Mr. Nami is an alumni of Bayero University, Kano and Ahmadu Bello University, Zaria. He is a Fellow of the Chartered Institute of Taxation of Nigeria (CITN) and Association of National Accountants of Nigeria (ANAN). He is also an Associate member of the Nigerian Institute of Management (NIM), Chartered Institute of Stockbrokers (CIS) and the Institute of Chartered Accountants of Nigeria (ICAN).

He started his career with PKF in 1993 and rose to become Senior Consultant with responsibilities for tax management and advisory services. He later became the Managing Consultant of Manam Professional Services (Chartered Tax Practitioners and Advisers) with offices in Kaduna, Abuja and Minna before he was appointed Executive Chairman of FIRS. He has successfully founded and managed many businesses individually and in company of other investors in the Agricultural and Power Sectors of our economy, Real Estate Development and Consultancy/ Advisory Services.

Mr. Nami would neither accept nor give anything short of excellence. Even after completing a successful tenure as the Executive Chairman of FIRS, he proceeded to the Harvard Kennedy School of Government where he earned Executive Certificate in Public Leadership after he successfully completed the following executive programs: Senior Executive Fellow of the University in April, 2025, Leading Economic Growth in December 2025 and Leadership in Crises, April 2026.
